# Description of the Rights

IORIGINALITY

## Basic Rights

NFT is for personal use only. The bought piece of art may be used on personal devices for personal use and social media, in public places for free and in exhibitions and events on a free entrance basis. But you can resell NFT on IORIGINALITY marketplace.

## Limited Rights

You can sell products using the NFT artwork but cannot give away or sell copies of the artwork itself. Redistribution is generally not allowed under a limited license. You cannot change the work, meaning use it in commercial ads, for example. However, in addition to the Basic Rights you obtain a right to copy the artwork, display it publicly and use it on media channels for profit.

## Full Rights

You can sell, share, or give away the artwork in any format, including physical products or digital copies. In addition to the Basic Rights and Limited Rights, redistribution is allowed with full rights. You can also modify the artwork and redistribute the modified versions. Moreover, you are not obliged to mention the author's name with the work.

## Basic Rights

You can

### **Make non-commercial copies, display publicly and distribute the artwork for personal use**

For example, you can create personal copies of the NFT artwork, take screenshots, photos and videos, copy your artwork and move it from one device to another, download it from the token or hidden content, display it or its copy on a screen at home or in any public spaces (like parks and squares or Metaverses) or create a gallery or another marketplace to make online and offline exhibitions on an entry free basis only. You can also send a copy to your friends, family and other people for free or print the artwork on paper or items like T-shirts and mugs and give them to someone as a gift.

**Imagine** you can download NFT as a jpg, print a poster at home and show it to friends. Or you can display it on screens at home, at public spaces like parks and even set up free exhibitions online or offline. ### **Use on any media channels for profit**

This means that: you can use your artwork on any media channels like metaverses and marketplaces without any other modification of your artwork for a fee.

## Full Rights

### **Authorship waiver**

When the Author forever waives all moral rights, the Author's name shall no longer be mentioned or included in the work.

### Commercial distribution of the artwork

### To make changes and derivatives of the artwork

Full Rights

### Assignment of all intellectual property rights

- You receive all IP rights on artwork.

That means you can transfer / fully sell (assign) the IP rights on an artwork and receive profit from this transfer or assignment.

### Authorship waiver
